- If there are any changes to the amount, date or frequency of your Direct Debit, Eazy Collect Re The Farmer Network will notify you 10 days in advance of your account being debited or as otherwise agreed. Eazy Collect Re The Farmer Network to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by either Eazy Collect Re The Farmer Network or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your Bank or Building Society. If you receive a refund you are not entitled to, you must pay it back to Eazy Collect Re The Farmer Network asks you to.
- You can cancel your Direct Debit at any time simply by contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
